

AGREEMENT.

THIS AGREEMENT MADE THIS FIRST DAY OF SEPTEMBER, ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SIX, BETWEEN MISS KATE M. SCOTT, OF BROOKVILLE, JEFFERSON COUNTY, PENNSYLVANIA, OF THE FIRST PART, AND D. MASON & CO., OF SYRACUSE, NEW YORK, OF THE SECOND PART, WITNESSETH:— THAT SAID PARTY OF THE FIRST PART HEREBY AGREES TO WRITE FOR SAID PARTY OF THE SECOND PART, THE HISTORY OF JEFFERSON COUNTY, IN THE STATE OF PENNSYLVANIA.

THE SAME TO CONTAIN NOT LESS THAN SIX HUNDRED PRINTED PAGES, SAME SIZE AS THE FIRST VOLUME OF THE HISTORY OF ERIE COUNTY, NEW YORK, PUBLISHED BY D. MASON & CO., AND EMBRACING SUBSTANTIALLY THE TOPICS SET FORTH IN THE PROSPECTUS RELATING TO THE HISTORY OF JEFFERSON COUNTY ISSUED BY PARTY OF THE SECOND PART, ONE OF WHICH IS ATTACHED TO THIS AGREEMENT, WHICH TOPICS SHALL BE TREATED IN A MANNER SIMILAR TO THAT FOLLOWED IN THE FIRST VOLUME OF THE HISTORY OF ERIE COUNTY, NEW YORK, PUBLISHED BY PARTY OF THE SECOND PART.

THE MANUSCRIPT TO BE WELL WRITTEN, AND CORRECT SUBSTANTIALLY AS FORMER PUBLICATIONS ISSUED BY PARTY OF THE SECOND PART.

SAID PARTY OF THE FIRST PART HEREBY AGREES TO FURNISH THE ENTIRE MANUSCRIPT OR COPY FOR SAID HISTORY, ON OR BEFORE THE FIRST DAY OF MARCH, ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SEVEN, UNLESS OTHERWISE MUTUALLY AGREED, AND TO FURNISH SUFFICIENT COPY TO PRINT ONE HUNDRED PAGES OF SAID JEFFERSON COUNTY HISTORY, ON OR BEFORE THE FIRST DAY OF DECEMBER, ONE THOUSAND EIGHT HUNDRED AND EIGHTY-SIX, ALL PROOF TO BE READ AND CORRECTED BY PARTY OF THE FIRST PART UPON THE RECEIPT

THEREOF, AND TO BE RETURNED AT ONCE AND WITHOUT DELAY TO THE PARTY OF THE SECOND PART.

THE PARTY OF THE FIRST PART FURTHER AGREE TO PREPARE FROM TIME TO TIME SUCH ITEMS FOR THE PRESS AS THE WORK MAY SEEM TO REQUIRE.

IN CONSIDERATION OF THE FOREGOING THE SAID PARTY OF THE SECOND PART HEREBY AGREES TO PAY TO SAID PARTY OF THE FIRST PART, THE GROSS SUM OF NINE HUNDRED (\$900) DOLLARS, PAYMENT TO BE MADE IN THE FOLLOWING MANNER, TO WIT:— SEVENTY FIVE DOLLARS UPON RECEIPT OF MANUSCRIPT SUFFICIENT TO MAKE THE FIRST ONE HUNDRED PRINTED PAGES SEVENTY FIVE DOLLARS UPON THE RECEIPT OF THE SECOND HUNDRED PAGES SEVENTY FIVE DOLLARS UPON RECEIPT OF THE THIRD HUNDRED PAGES ONE HUNDRED DOLLARS UPON RECEIPT OF THE FOURTH HUNDRED PAGES ~~ONE HUNDRED~~ ONE HUNDRED DOLLARS UPON RECEIPT OF THE FIFTH HUNDRED PAGES ONE HUNDRED <sup>dollar</sup> UPON THE RECEIPT OF THE MANUSCRIPT FOR FINAL ONE HUNDRED PAGES AND EXCESS IF ANY TO FINISH THE BOOK, THE BALANCE THREE HUNDRED AND SEVENTY FIVE DOLLARS TO BE PAID OUT OF THE FIRST MONEY COLLECTED FROM THE DELIVERY OF SAID JEFFERSON COUNTY HISTORY TO SUBSCRIBERS.

PARTY OF THE SECOND PART FURTHER AGREES TO PAY TO PARTY OF THE FIRST PART, THREE DOLLARS EACH, FOR WRITING AND GETTING APPROVED ALL BIOGRAPHIES WRITTEN IN CONNECTION WITH THE PORTRAIT DEPARTMENT OF JEFFERSON COUNTY.
